## **Advocacy Agenda Updates Approved**

The TASB Board approved the proposed changes to the 2018–20 Advocacy Agenda Priorities and new and amended resolutions for submission to the 2019 Delegate Assembly for final adoption. The Assembly is set to meet September 21 during the 2019 TASA | TASB Convention, txEDCON19, in Dallas. The Delegate Assembly Handbook with the proposed changes under consideration will be posted in early September.

Ross Ramsey, executive editor and cofounder of *The Texas Tribune*, will visit the TASB Delegate Assembly to share his insights on the 86th legislative session.

### 30 years, 30 rebates

2019 marks the 30th year that 100 percent of local school boards have renewed their TASB membership. To celebrate, <u>TASB will rebate</u>

<u>Convention registration fees</u> for 30 lucky local school boards that send representatives to attend Delegate Assembly. (Up to eight registrations will be rebated per winning district.) Your school board must participate in the 2019 Delegate Assembly to be eligible.

#### **Delegate Registration**

Each local board may appoint one delegate and one alternate for the Assembly. Take action this summer to ensure your board is represented at Delegate Assembly. Preregister your representatives by August 19 to receive Assembly credentials by mail. Onsite registration also will be available.

# **Advocacy Institute Stipend Application Open**

TASB is offering a <u>stipend for school board members interested in attending the National School Boards Association's Advocacy Institute</u>. This annual event is an opportunity for school board members across the nation to gather in Washington, DC, and advocate for public schools. The 2020 event is set for February 2–4.

The conference is the only national legislative event exclusively for school trustees. TASB's goal is to have a representative from each Texas congressional district at the conference. This year, 65 Texas school board members attended the conference. The TASB Board awarded 24 stipends to districts for trustees to register for the conference

Local school boards may nominate a trustee and alternate to represent their local boards. The stipend covers the cost of the conference registration and is paid directly to your district. Recipients must pay for accommodations and transportation to and from Washington, DC.

# Officer Nominations Slate Approved

## **Legislative Summary Now Available**

## **New Training Requirements for Trustees**

During the 86th legislative session, lawmakers made changes to trustee training requirements. Two additional training requirements were adopted:

• House Bill (HB) 403 requires training on recognizing sexual abuse, human trafficking, and other maltreatment of children. The Department of Family and Protective Services (DFPS) has a one-hour training for educators that could meet this requirement. In previous years, Christina Green from Child Advocacy Centers of Texas (CACTX) provided sessions at TASB events that should qualify for meeting this requirement. Green is scheduled to present again at the 2019 TASA | TASB Convention. TASB will share more information as the training is finalized.

· HB 3834 requires training on cybersecurity.

The Texas Department of Information Resources (DIR) is going to approve up to five online options. TASB hopes to become one of the approved providers for this training. Local school districts can develop their own training with certain requirements that include a cybersecurity officer on staff and that the course be subject to an audit. The deadline to complete this training is June 14, 2020—one year after the legislation was signed.

Not a training requirement, per se, but HB 3 does include a new requirement for school boards to complete goal setting. Every district must have specific goals on early childhood literacy and numeracy and a college, career, and military readiness goal. These goals must be adopted by the local school board and displayed on the district website. TASB staff will be helping districts develop these goals. The Texas Education Agency is scheduled to release rules on these requirements in September.

## TASB Risk Management Fund

The <u>TASB Risk Management Fund</u> offers liability, workers' compensation, auto, property, unemployment compensation, and data breach/privacy coverage to TASB members.

- More than 1,000 members
- · More than \$320 million in assets
- Designated high-tier performer by the Texas Department of Insurance for seven consecutive times, and one of only two carriers to have this distinction
